



Boarding & Daycare Contract

This Contract is between **Baxter & Beasley** (hereinafter called "Kennel") and the pet owner whose signature appears below (hereinafter called "Owner").

1. Owner agrees to pay the rate for boarding/daycare in effect on the date pet is checked into the Kennel.
2. Owner agrees to pay any additional night charges if pet's stay is extended for any reason.
3. Owner agrees to pay all costs and charges for special services requested, and all veterinary costs for the pet during the time said pet is in the care of Kennel.
4. Owner agrees that the pet shall not leave Kennel until all charges are paid to Kennel by Owner.
5. Owner is responsible for the costs of any veterinary expenses, should the pet become ill or if the pet requires medical attention, the Kennel, in its sole discretion, may engage the services of a veterinarian or other medical professional for the care of the pet.
6. By signing this contract, Owner agrees that Kennel has full permission to use any picture, likeness, or image of the pet for marketing purposes or on the internet on social media sites.
7. Owner specifically represents to Kennel that he or she is the sole owner of the pet, free and clear of all liens and encumbrances.
8. Owners specifically represents to Kennel that the pet has not been exposed to rabies, distemper, parvo virus, or other contagious diseases within a 30 day period prior to boarding.
9. By signing this Contract and leaving the pet with the Kennel, Owner certifies to the accuracy of all information given about said pet and further certifies that no information requested by Kennel or otherwise necessary for Kennel's proper care of the pet has been omitted or withheld by Owner.
10. All incoming new pets are issued a paper collar. These are temporary collars used for the safety of the pet until Kennel staff is familiar with the pet.
11. Owner specifically acknowledges that Kennel is not responsible for loss or damage to any personal item or toy left with your pet. Do not bring items with your Pet that are valuable or irreplaceable.
12. KENNEL'S LIABILITY SHALL IN NO EVENT EXCEED THE LESSER OF THE CURRENT CHATTEL VALUE OF A PET OF THE SAME SPECIES OR THE SUM OF \$400 PER ANIMAL BOARDED. THE OWNER FURTHER AGREES TO BE SOLELY RESPONSIBLE FOR ANY AND ALL ACTS OR BEHAVIOR OF SAID PET WHILE IT IS IN THE CARE OF KENNEL INCLUDING VETERINARY BILLS INCURRED FOR ANY PET AS A DIRECT RESULT OF SAID PET'S BEHAVIOR. ADDITIONALLY, ANY MEDICAL BILLS INCURRED BY KENNEL'S STAFF OR CUSTOMERS AS A RESULT OF SAID PET'S BEHAVIOR SHALL BE THE OWNER'S RESPONSIBILITY.
13. OWNER SHALL INDEMNIFY AND HOLD HARMLESS KENNEL FROM ALL FINES, LEVIES, SUITS, PROCEEDINGS, CLAIMS, ACTIONS, CAUSES OF ACTION, OR DAMAGES OF ANY KIND AND WHATSOEVER NATURE, INCLUDING BUT NOT LIMITED TO ALL COSTS, COURT COSTS, LITIGATION EXPENSES AND REASONABLE ATTORNEY'S FEES, AND MEDICAL EXPENSES ARISING FROM, GROWING OUT OF, IN CONNECTION WITH, OR INCIDENTAL TO OWNER'S PET'S BEHAVIOR OR OWNER'S VIOLATION OF THIS CONTRACT.
14. All charges incurred by Owner shall be payable upon pick-up of pet, or when billed by Kennel at the address listed on Contract. Kennel shall have, and is hereby granted, a lien on the pet for any and all unpaid charges resulting from boarding the pet at Kennel. If Owner does not pick up the pet within 14 calendar days after the day the pet was due to be picked up, the pet shall be deemed to be abandoned. The person into whose custody the pet was placed for care shall first try for a period of not less than 14 days to find a new owner for the pet, and, if unable to place the pet with a new owner, shall thereafter humanely destroy the pet so abandoned.
15. In the event that Owner breaches this Contract in any way or Kennel reasonably determines that, by fulfilling its obligations to Owner with respect to boarding Owner's pet, it will be endangering other pets or individuals, Kennel shall have the right to discontinue its boarding of the pet and immediately require Owner to retrieve the pet from Kennel's care. Notwithstanding Kennel's exercise of this right, Owner shall still be required to pay to Kennel the full agreed-upon Contract price as if Kennel's boarding of the pet had not been terminated prematurely.
16. By signing this contract, Owner acknowledges receipt and acceptance of Kennel's policies and procedures including but not limited to our cancellation policy.

17. This Contract attached hereto contains the entire agreement between the parties. All terms and conditions of this Contract shall be binding on the heirs, administrators, personal representatives and assigns of Owner and Kennel.
18. Any controversy or claim arising out of or relating to this Contract, or the breach thereof, or as the result of any claim or controversy involving the alleged negligence by any party to this Contract, shall be settled by arbitration in accordance with the rules of the American Arbitration Association, and judgment upon the award rendered by an arbitrator may be entered in any Court having jurisdiction thereof. Notwithstanding such arbitrator's decision, Owner shall be solely responsible for all legal costs and attorney fees incurred by Owner and Kennel in relation to such arbitration and/or litigation.
